Whole body/finger/eye lens dosimeter(s) will be issued and/or radiation monitoring service will be provided only after the appropriate fee are paid by the client.

在正式發放全身/指環/眼睛晶狀體劑量計及或提供輻射監察服務前，用戶必須先行繳付有關費用。

The service includes the monthly processing of one whole body/finger/eye lens dosimeter returned by each user, and the maintenance of the said dosimeter. Unless the user collects from or returns to the Radiation Monitoring Service his/her dosimeter(s) by hand, the dosimeter(s) will be mailed (from the Radiation Monitoring Service to the user and vice versa) at the user's own risk. The user will be responsible for any loss of and/or damage to the dosimeter(s).

服務本身包括按月處理由用戶交回的每隻全身/指環/眼睛晶狀體劑量計，以及為該劑量計提供保養。除非用戶的劑量計是以專人收取或交回輻射監察服務處，否則一般劑量計將會以郵寄方式交收。如劑量計遺失及或出現損壞，一概由用戶負責。

The service fee is charged for each financial year from 1 April to 31 March of the following year. If a user joins the service after commencement of a financial year, he will have to pay for the cost of the service from the month when the service is commenced until the end of the financial year. No refund will be made if the user wishes to stop the service before expiry of the service period for which payment has been made.

COLLECTION OF PERSONAL DATA

INTRODUCTION

1. This document briefly describes your rights and the means to request access to and correction of your personal data held by the Radiation Monitoring Service, Radiation Health Division, Department of Health.

PURPOSE

2. The Radiation Monitoring Service, Radiation Health Division uses the personal data provided by the clients for the delivery of services and other related activities. The provision of personal data is obligatory under Radiation Ordinance, Cap.303 and its subsidiary regulations. The personal data provided will be used by us for the below listed purposes. If the necessary information are lacking, we may not be able to provide the required services:

- (a) Proof of eligibility;
- (b) Processing of applications for radiation monitoring service, the provision of radiation monitoring service and management of personal dose history;
- (c) Processing of applications/permits by the Radiation Board;
- (d) Assessment of fitness for employment in radiation work by the Radiation Board;
- (e) Preparation of general demand note;
- (f) Collection of service charges; and
- (g) Enforcement of the regulatory requirements of Radiation Ordinance, Cap 303 by the Radiation Board.

HANDLING OF INFORMATION

3. The personal data you provide are mainly used by us for the above purposes but they may also be disclosed to other Government bureaux/departments or relevant parties for the purposes mentioned in paragraph 2 above, if required. Besides, the data may only be disclosed to parties where you have given consent to such disclosure or where such disclosure is allowed under the Personal Data (Privacy) Ordinance.

ACCESS TO PERSONAL DATA

4. In accordance with Sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance, (Chapter 486 of the Laws of Hong Kong), you have the right to request access to and correction of the personal data supplied in your application.

引言

1. 本文件告訴你有關查閱及修改你存記於衛生署放射衛生科輻射監察服務的個人資料及其辦法。

收集個人資料的目的

2. 放射衛生科輻射監察服務收集個人資料，是為客戶提供服務及進行其他有關活動。根據輻射條例，提供個人資料是強制的。我們收集的個人資料有以下用途，如果所需的資料不完備，我們可能無法為你提供有關的服務：

- (a). 核實資格;
- (b). 處理輻射監察服務的申請、提供輻射監察服務及管理個人輻射劑量記錄;
- (c). 為輻射管理局處理牌照/許可證的申請;
- (d). 為輻射管理局評定是否適合擔任輻射工作;
- (e). 處理一般繳款單;
- (f). 收取相關服務費用; 以及
- (g). 為輻射管理局執行輻射條例第 303 章的法例要求

處理個人資料

3. 你所提供的個人資料，主要作為上述第2段所列出的用途，但亦可能在有需要時就上述第2段有關的用途向其他政府部門及有關人士披露。屆時有關披露將會是基於你的個人意願或按照個人資料(私隱)條例所允許的情況下進行。

4. 根據個人資料(私隱)條例(香港法例第486章)第(18)及(22)條及附表1第6原則，你有權查閱及更改申請書內所提交的個人資料。
